A Settlement has been reached with The Wolf Firm, A Law Corporation (the "Wolf Firm") in a class action lawsuit claiming that it violated the Rosenthal Fair Debt Collection Practices Act ("RFDCPA"); and, the Fair Debt Collection Practices Act ("FDCPA") by sending written communications that allegedly included confusing language and is alleged to have omitted other required disclosures, in between July 8, 2015 and X ("Class Period"). The Court did not decide in favor of Plaintiffs Rosa; and, Javier Calderon ("Plaintiffs") or the Wolf Firm, and the Wolf Firm denies any violations occurred. However, to settle the case, the Wolf Firm has agreed to provide for a Settlement Fund to compensate the class members and to pay notice costs as well as attorneys' fees; and, litigation costs.

The Wolf Firm's records indicate that you may be included in the Settlement because it sent you one of the demand letters at issue in the Action.

Included with this letter is a check in the amount of \$15.66. Class Members will also benefit from the fact that the Wolf Firm will no longer use the demand letter at issue in this Litigation.

If you do not want to be legally bound by the Settlement, you must exclude yourself from it by XXXX, XX, 2017. Unless you exclude yourself, you will not be able to sue Defendant and related entities for any claim made in this lawsuit or released by the Settlement. If you stay in the Settlement, you may object to it or ask for permission for you or your own lawyer to appear and speak at the fairness hearing—at your own cost—but you do not have to. The Court will hold a fairness hearing on XXXX, XX, 201X, at X:XX a.m., in Courtroom X at the United States District Court, Central District of California, 411 West 4th Street, Santa Ana, CA 92701, to decide whether to approve: (1) \$68,000 the Settlement which includes attorneys fees, litigation costs, and any fees paid to the Calderons, (2) attorneys' fees and litigation costs, and (3) a \$2,000 payment to each of the Calderons.
